

**SINGLE USER LICENSE AGREEMENT AND LIMITED WARRANTY FOR
TECHNICAL PANELS CO., LTD. SECURITY SOFTWARE**

By receiving armored CIT vehicles modified by Technical Panels Co., Ltd. you accept all of the following TP Technical Panels Software License Agreement. **IMPORTANT - READ CAREFULLY BEFORE USING THE VEHICLE SOFTWARE.**

By using any portion of the software, you accept all of the following Technical Panels Co. Ltd. Single User License Agreement.

This is a legal agreement between TP Technical Panels (called following TP) and you, the end user.

SOFTWARE LICENSE

TP grants you the right to use a copy of the software on a single device per vehicle. In the case of auxiliary systems, such as the Code Generator, TP grants you the right to use a copy of the software on a single device. Copyright and other intellectual property laws and international treaty protect this software. Copyright law prohibits you from making any other copy of the software without the permission of TP. You may not alter, modify, or adapt the software or create any derivative works based on them. TP distributes the software in a tablet executable form only, and does not allow user access to the underlying source code and data. You may not reverse engineer, decompile, or disassemble the software to gain access to such code and data. Decompiling or disassembling the software may also violate the software's copyright.

You may not sublicense, sell, rent, lend, lease, sublicense, or give away the software to others. You may not transfer this license. Any unauthorized copying, distribution, or modification of the software will automatically cancel your license to use the software and violate the software's copyright.

LIMITED WARRANTY AND REMEDIES

TP warrants that the software will perform in substantial compliance with the specifications provided that it is not modified and it is used on the vehicle and the change computer hardware and with the operating system for which it was designed. TP also warrants that any disk media it provides are free from defects in materials and workmanship under normal use. These warranties are limited to the 90-day period from receiving the vehicle. If you report in writing within 90 days of receiving the vehicle a substantial defect in the software's performance, TP will attempt to correct it. If you return faulty media or a printed user manual during this period, along with a dated proof of purchase, TP will replace it free of charge. You must insure items being returned, since TP does not accept the risk of loss or damage in transit.

The warranties and remedies set forth above are exclusive and in place of all others, oral, or written, express or implied. TP does not and cannot warrant the performance or results you may obtain using the software. Except for the forgoing limited warranty and remedies, and for any warranty, condition, representation, or term to the extent to which it cannot or may not be

excluded or limited by law applicable to you in your jurisdiction, TP makes no warranties, representations, or conditions, express or implied, with respect to the software, satisfactory, no infringement of third party rights, integration TP will in no event be liable for any direct, indirect, special, incidental, or consequential damages arising from the use the software.

Because software is inherently complex and may not be completely free of errors, TP is not responsible for any costs including, but not limited to, lost profits or revenue, loss of time or use of the software, loss of data, the cost of recovering software or data, the cost of substitute software, claims by third parties, or similar costs. In no event will the liability of TP exceed the amount paid for the software.
